



## PRACTICAL INFORMATION FOR IAC-25 PARTICIPANTS

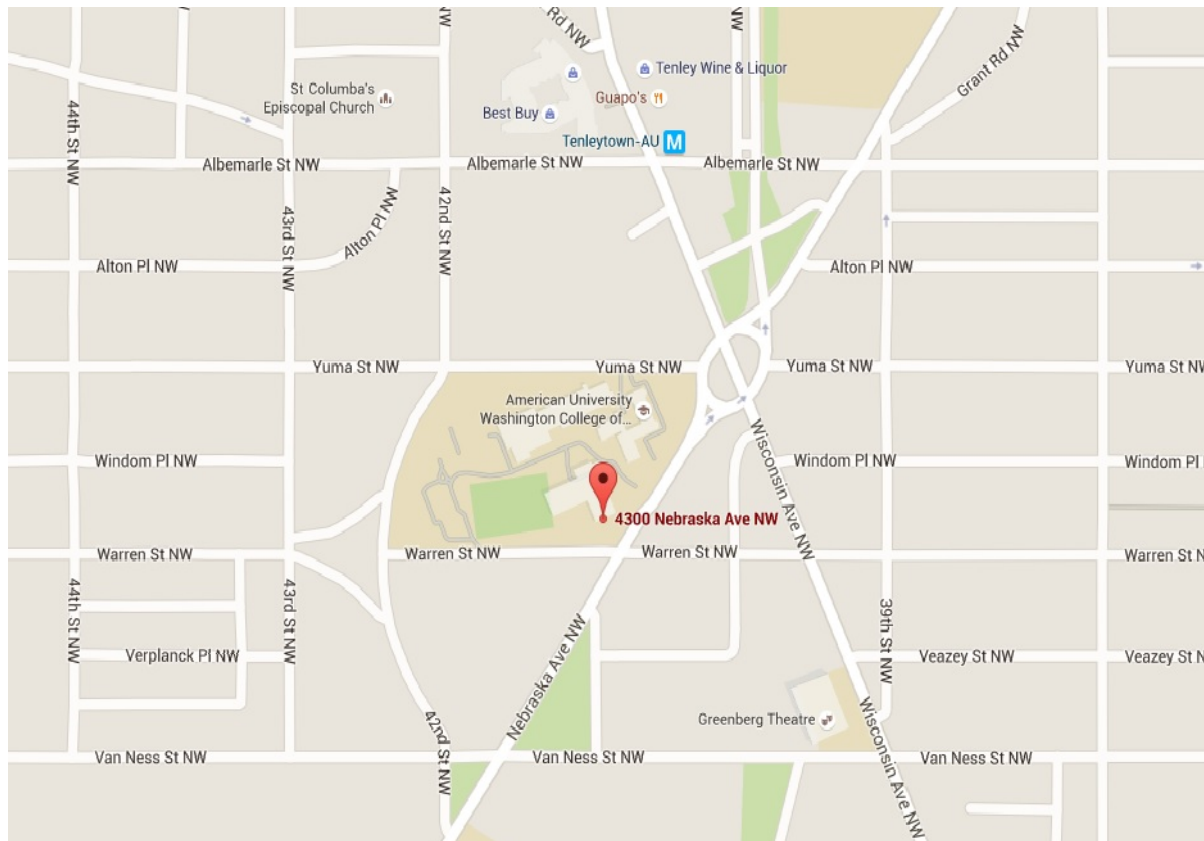

The Washington College of Law is located at Nebraska Avenue N.W., Yuma Building, Terrace Level, Claudio Grossman Hall, Washington DC 20016, in the upper northwest section of Washington, D.C.

**Please note that this is about 0.5 miles east of the main American University campus.**

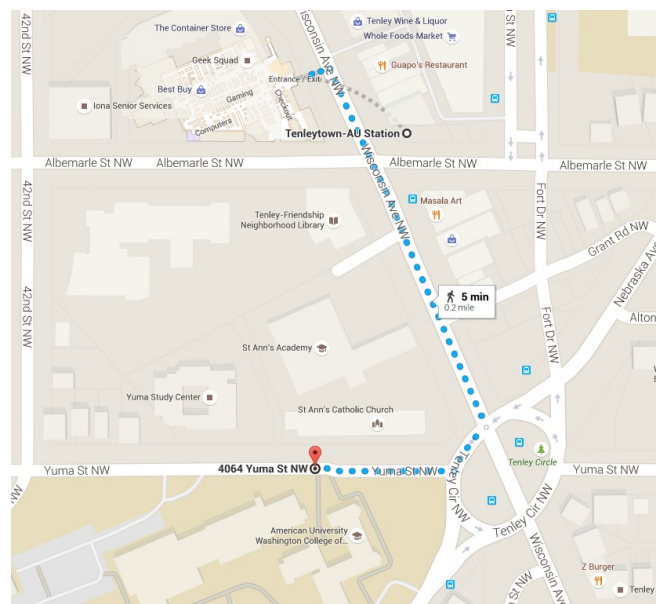


## METRO SYSTEM

Washington's Metrorail system opens at 5 am on weekdays and 7 am on weekends, closing at midnight Sunday through Thursday and 3 am on Friday and Saturday nights. The closest Metro stop to The American University is Tenleytown/AU on the Red Line. Public Metro buses run on regular schedules from several areas around DC and Maryland.

The Washington College of Law campus is located one block (0.3 miles) east of the Tenleytown-AU Metro station. From the Metro station, walk east on Wisconsin Avenue one block to Tenley Circle, turn right onto Tenley Circle, and right again at Yuma St. NW. The pedestrian entrance will be on the right. Enter through the Yuma Building entrance.



## TAXICAB

When using taxi service, be sure to instruct the driver to take you to 4300 Nebraska Ave NW. rather than just to American University, because the Washington College of Law is not situated on the main AU campus. If you need a taxicab, please call:
